

Addventure ADHD Coaching, LLC Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.adhdaddventure.com, and Addventure ADHD Coaching and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Addventure ADHD Coaching include www.adhdaddventure.com. The Addventure ADHD Coaching website is a ADHD Coaching site. By using the Addventure ADHD Coaching website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Addventure ADHD Coaching may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Addventure ADHD Coaching's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Use of your Personal Information

Sharing Information with Third Parties

Addventure ADHD Coaching does not sell, rent or lease its customer lists to third parties. Addventure ADHD Coaching may share data with trusted partners to help perform statistical

analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these

Tracking User Behavior

Automatically Collected Information

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
